When logging in to the old app you will be prompted to the new app. After downloading the new app you simply use your existing user name and password.

Dear Member,

On April 15th we will begin our Club Loan programs for 2018. This year we will offer 3 loans beginning on April 15th for mobile and on-line disbursements (all in-office disbursements will be 10 days later). No loans will begin before that date and we will run the program for a 30-day window of access.

The next loan dates will be August 15th and November 15th.

If you are a current user of the Club Loan Program (have had one or more club loans in the past) please review your accounts. The program will require a full Direct Deposit of your salary to a credit union account to be in place for at least 2 months. All club accounts and prior club loans (or other PFCU loans) must be in good standing. Members are only allowed 3 club loans at a time so if you have a small balance from a previous club loan please send us an email to transfer club funds to pay it off. Please test your ability to use our mobile app or on-line service.

If you are a current member who has not had a Club Loan in the past please apply as soon as possible using our on-line application (use the "button" on our web site). This should take no more than a few minutes. Our office staff can then go over your account and have you set up for the April 15th date.

If you are not a member of the credit union please come in to one of our branches, or contact the email address below to have a new account started.
